

Summary	All new students or students who have been out of attendance for over 365 days who i) apply for and enroll in a University of Phoenix bachelor's degree program; (ii) have three year's work experience and (iii) apply for this Phoenix Bachelor's Scholarship – June 2024 ("Scholarship") prior to the deadline and register and post attendance in their first class between June 1 <sup>st</sup> , 2024 and June 30 <sup>th</sup> , 2024 ("Initial Attendance Window") will receive a scholarship worth up to a maximum of \$1,000 each, distributed over 20 courses.

  - c. Applicants pursuing stand-alone University of Phoenix certificates.
  - d. Applicants pursuing a Competency Based Education program.

  - f. University of Phoenix Alumni
  - g. Applicants receiving any employer benefits or discounts
  - h. Applicants receiving Military Tuition Rate
  - i. Applicants who are receiving the AA Transfer tuition rate

6. The Scholarship will automatically terminate if:
  - a. Applicant fails to meet the eligibility requirements

  - c. Recipient is out of attendance on an unapproved leave of absence for more than 35 days.
  - d. Recipient completes their bachelor's degree program.
  - e. Receives the maximum scholarship award
  - f. Two years (730 days) from the start date of recipient's first course notwithstanding any approved leave of absence(s).

If recipient has applied for or is receiving Title IV financial aid funding, this scholarship may reduce the recipient's eligibility for Title IV financial aid funding to comply with Title IV regulations.
